Notes to the Donor

- 1) If you pay tax in the UK completing the Gift Aid Form overleaf will allow us to reclaim income tax upon your gift to Rugby School. It can also apply to any future gifts to Rugby School which you may make. There is however, no future obligation implied.
- 2) If you are a higher rate taxpayer, you will yourself be able to claim higher rate tax relief on your Self Assessment tax return. This is the difference between the basic rate and higher rate of tax on your gift and reduces the cost to you of making the gift.
- 3) If you have decided to make a gift please send the completed Gift Aid Form to the Rugby School Development Office (address overleaf) together with your cheque made payable to **Rugby School - Rugby Fives Appeal**.
- 4) Please remember to notify the Rugby School Development Office if in the future you no longer pay an amount of income tax and/or capital gains tax equal to the tax we will reclaim on your donations.
- 5) All donations of shares to a charity will receive tax relief of 100% of their market value. If you would like more information on gifts of shares, please contact the Development Office.
